Board's Report

South Lake

The board voted to get approval for expenditures to bring the south lake up to true lake status. The expenditures will be used to install a solar pump to add water as needed. This may be a temporary fix pending resolution of the claim against the developer.

Financial Report

No special assessment was approved at this time for ongoing financial needs, but there are future issues that may require expenditures requiring a special assessment. None of us want this, but we may need it. The financial report for 2005 is enclosed.

Water Availability: Fire and Power Outage

Due to continued questions about the fire protection and response, we will try to get a representative from the fire department for an informational meeting concerning the capacity to pump water from hydrants in the event of a power outage or fire. Fire trucks have their own pumps on board, so there seems little chance that we would be without water. Some residents would like a back-up generator available for the pumps. This generator would work to get water to the southern lots.

Scooter Vote

The vote on amending the CC&Rs to allow for electric scooters was 13 YES and 18 NO. Therefore the board will not proceed at this time with further action.

4-H Project

The Board has granted a request to have a 4-H project involving lambs on private property (Roberts) for a short term. They will be gone, and the pens removed by August.

Spotlight on Our Wildlife

Many of you have seen the lone coyote wandering the hillsides in the morning, but few of you have seen the red foxes we have, and I am not sure any of you has seen the kit foxes we are supposed to have. Here is why: Kit foxes (listed as endangered) are very shy, nocturnal, and they haven't adapted to living near people as well as their larger cousins. Kits are about the size of a large domesticated cat, and we are supposed to have a den of them in the canyon by Vista de la Vina.

Red foxes have an altogether different personality and I have seen them roaming the canyons in Spanish Lakes. They are bold, but unlike their larger grey fox relatives, do not climb trees. I have not seen the shy grey around here.

The coyotes are larger, of course, than the foxes, and have adapted very well to living near humans. They traverse a set territory in a timely manner, marking their space religiously.

All of these creatures munch of rodents, which we have aplenty. Speaking of which, those muskrats you may have seen at the lake are members of the rodent family.
