### Water Board Update

In the absence of a quorum at the water board meeting, an election of new members was not possible; consequently, current members will stay on another year and new members will be appointed. Bernie Kempker was appointed as a new member for this year, and will join President Pat Munks, Tom Lawson, and Jim Hagen. Craig Thomas has volunteered to do research on the cost of replacing tanks, pumps, and other items in an effort to plan for future expenditures from reserve funds. Currently, it seems that there may be adequate reserves to cover future expenditures. The Water Board has been granted a tax-exempt status. Since this tax free status is retroactive, the Board will seek taxes paid in the past.

### Board's Report

#### Gate Monuments

You have received a packet from Mark IV with drawings and description of the proposed gate monuments. Your input will help us make the right choices.

#### Renting the Open Space Triangle

From the last Newsletter, you will remember the possibility of renting use of the "PGE triangle" by an owner of the adjacent land. It turns out that the owner prefers to rebuild the fallen fence so his stock cannot wander into our space. We will watch for some progress on this front.

#### Drainage Abatement

Many of the drainage problems now have been repaired. After the rainy season is over, the Board will determine if there are other drainage problems that need to be addressed this summer.

#### Work Day

In May, there will be a workday to clean up our open space. The Pickerings will treat volunteer workers to a free lunch. Roger Zolldan

will organize the event and get the particulars to us soon. Come one, come all—it should be fun.

#### Speeding

Speed humps were once again discussed, but it was decided to add a few strategically placed signs instead. In the event these do not slow the traffic, speed humps will once again be considered. There have been complaints that cars have almost mowed several of us down. The concern here is not only for our wildlife, and walkers, but also for children who enjoy light traffic. Many steep driveways lead out to main streets, and children aren't always cautious about their downhill bike or skating speed.

#### Gate Code Change

The gate code will change on March 15. There will be two codes, one for residents and one for contractors. Please use the contractor's code for infrequent visitors and the owner's code for your immediate family. The contractor's code will be changed more frequently. A copy of the two codes is enclosed.

#### Landscaping Pump Houses

We are asking the water company to soften the appearance of the pump house at the intersection of Laguna Del Campo and Calle Los Charros. Only native vegetation will be used and access doors will not be restricted. Since the other two pump houses are less obtrusive, it was decided to leave those as they are for now.

#### Weed Control

Recently an inspector visited us from the U.S. Dept. of Natural Resources. With regard to weed abatement she recommended mowing or string trimming instead of using chemical herbicides. Surface scraping around the lakes was particularly discouraged, as this contributes significantly to erosion and eventual sedimentation of the lakes. Please make an effort to comply with her directive that under no cir-

cumstances should owners do any surface scraping in common areas.

### **Repeat Offenders**

Unfortunately the Board is wasting considerable time sending and resending warning letters to CC&Rs violators. It was unanimously approved that owners who have received previous notification of violation of section 6.04 be subject to an automatic \$75 fine for further violations that occur for more than 60 hours during any 14-day period. Section 6.04 is reprinted below:

6.04 Temporary Structures, Boats, Commercial and Recreational Vehicle Restrictions: No structure of a temporary character, trailer, camper, mobile home, recreational vehicle, boat, inoperable automobile, or similar equipment shall be permitted to remain on any area within the Project, including the development envelope, without the prior written consent of the Committee. No noisy or smoky vehicles shall be operated on the lot. No unlicensed motor vehicles shall be operated outside the development envelopes.

### **Lake Viewing Chairs**

The association has acquired two Adirondack chairs for use by homeowners and their invited guests. We will place these chairs by the lake adjacent to the park. If you have any thoughts on their placement for optimun viewing, please let us know. Enjoy.

### **Plants That Don't Care If It Gets Real Cold**

The Western Garden Book, available at most nurseries for reference, lists our area as Zone 7. The nurseries, however, sell plants for Zones 8 and above also, for people who live in more temperate zones. Here are some plants that may survive freezing nights:

Coyote plants; Rosemary; Colorado Gold Gazania; Rockroses; Strawberry bushes/trees; Live Oaks; Olive trees; Pyracantha; Holly; Firs, Redwoods; Cypress; Phormium; New Zealand flax; Toyon; Butterfly Bush; Manzanita; Grevillia; Euonymus.

Many of the plants that look dead such as the California fuchsias will come back; so don't yank them quite yet. By the way California fuchsias are highly invasive, so it is a good idea to plant them in a contained area if you don't want them to spread. Most of the lavenders will not die completely; only look unhappy in the cold. If you have plants to add to our list that did well in your garden, let me know and I will add them to the next newsletter.

### **Focus on Our Wildlife**

#### **The Roadrunner at our Gate...**

I hope you have seen this unmistakable bird scooting across the field near the Creston gate. It is an omnivore, and eats insects, rodents, snakes, and small birds. It makes its nest on the ground or in low bushes.

This unique bird is 23 inches long, has a long, solid beak, and even longer tail that it often flicks upward. The head has a bushy crest, and its color overall is brown with some white striping. It is a member of the cuckoo family. The roadrunner is a ground dweller and seldom flies. It got its name by running across and along roads to escape rather than by flying. Unlike the beep-beep the coyote and roadrunner cartoon features, this bird has a cooing sound going down in pitch. Even so, when I see it, I smile and inadvertently mutter, "Beep beep."
